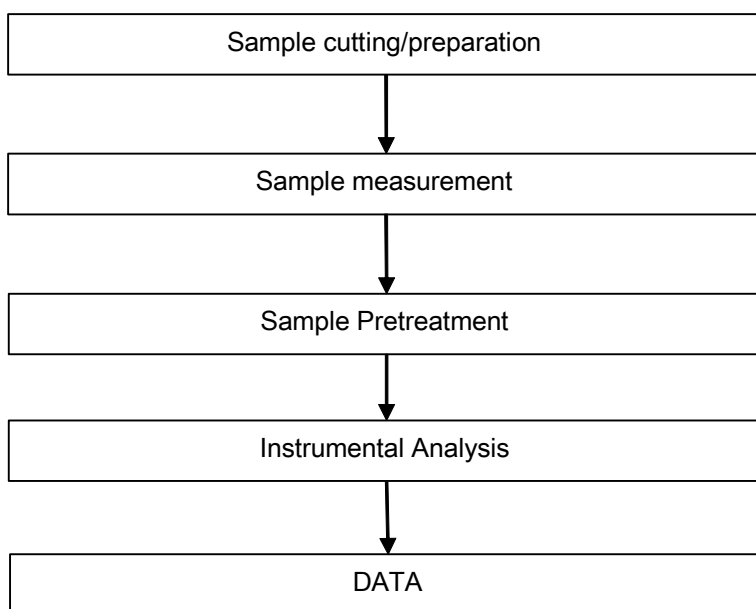

SVHC Testing Flow Chart



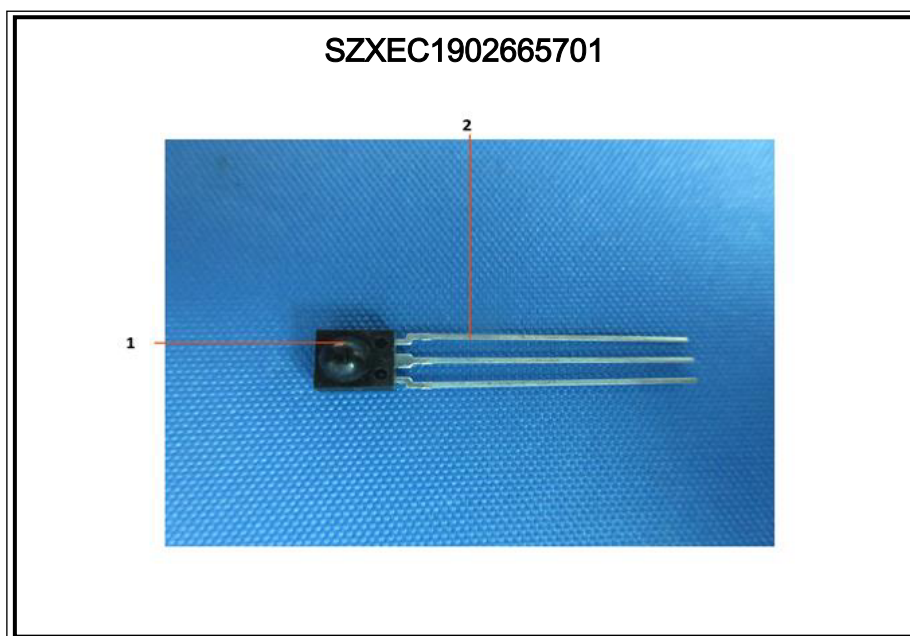
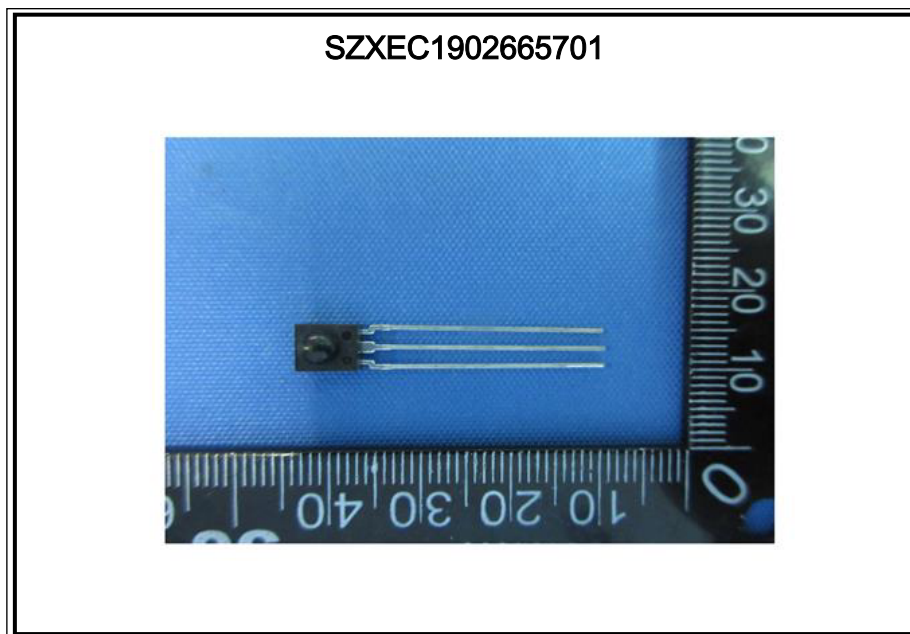
